Govt of Sindh to Establish Judicial Commission in the Late Mir Raza Ali Khan Case



STAFF REPORT, KARACHI: The Government of Sindh extends its deepest sympathy and heartfelt solidarity to the family of late Mir Raza Ali Khan. The profound grief of losing a loved one, particularly when serious concerns remain unanswered, is fully understood. No words can lessen the family's pain, and the family deserves transparency, reassurance and a fair examination of every concern raised by it.

The letter addressed by the family to the Chief Minister Sindh has been received with compassion and the utmost seriousness. After carefully considering

the concerns expressed by the family, the government of Sindh has decided to request the honourable Chief Justice of the Sindh High Court to establish a Judicial Commission to conduct an impartial and transparent inquiry.

The Commission shall determine whether the investigation in the case is being conducted impartially and in accordance with law. It shall also identify any investigative angle or evidence requiring further investigation.

The Commission shall further determine whether any police officer, medico-legal officer or other official committed

negligence, dereliction of duty, professional misconduct, suppression or manipulation of evidence, or any unlawful act, omission or cover-up. The commission may recommend further investigation, forensic analysis and appropriate legal or departmental action wherever warranted.

For the effective discharge of its mandate, the Commission shall exercise all powers available to it under the Sindh Tribunals of Inquiry Ordinance, 1969, including the powers of a Civil Court to summon and enforce the attendance of witnesses, examine them on oath, and require the discovery and production of

documents and other records.

All government departments, agencies and officials have been directed to extend full cooperation to the Commission and provide every record, document and form of assistance sought by it. The Home Department shall provide the necessary secretariat support.

The Commission shall submit its report, together with its findings and recommendations, to the Government of Sindh within 30 days of its constitution, or within such extended period as may be allowed where necessary for a complete and fair inquiry.

Bangladesh signals openness to joining Pakistan-Saudi-Turkiye defence agreement

MONITORING DESK, Bangladesh has signalled that it is open to joining the Makkah Joint Defence Agreement between Pakistan, Saudi Arabia and Türkiye, as Dhaka seeks to expand its strategic partnerships while keeping national interests at the centre of its foreign policy, it



emerged on Saturday, according to state-run Bangladesh Sangbad Sangstha (BSS).

"Bangladesh maintains a positive approach towards the possibility of joining an economic or defence framework involving Saudi Arabia, Pakistan and Türkiye, taking into account its own interests and the changing dynamics of the global economy and trade, said Bangladesh Prime Minister's Adviser for Foreign Affairs Humayun Kobir. Kobir said Bangladesh was pursuing a balanced foreign policy under its "Bangladesh First" approach in the international arena, with national interests at its core.

"Bangladesh is strengthening its working bilateral relationship with Pakistan as part of normal diplomatic engagement, with a focus on trade and bilateral people-to-people connectivity," he said. Kobir said Prime Minister Tarique Rahman's visit to Riyadh, at the invitation of Saudi Crown Prince and Prime Minister Mohammed bin Salman, was likely to be finalised soon after the summer. The remarks come just over two weeks after Pakistan, Saudi Arabia and Türkiye signed the Makkah Joint Defence Agreement in Makkah on August 7. Under the pact, an armed attack against any one of the three signatories is to be regarded as an attack against all three. The agreement also envisages broader defence cooperation and collective deterrence. Turkish Foreign Minister Hakan Fidan has described the arrangement as technically similar to NATO's Article 5 mutual-defence provision, while stressing that it is not directed against Iran or any other country.

Sindh govt again seeks SHC judicial commission to probe Mir Raza murder case

STAFF RPEORT, KARACHI: The Sindh government has once again decided to request the chief justice of the Sindh High Court (SHC) to constitute a judicial commission to investigate the murder of Mir Raza Ali, the Sindh chief minister's spokesperson said on Sunday.

Soon after the killing, the Sindh government had decided to constitute a judicial commission headed by an SHC judge to oversee a transparent and impartial investigation. It later deferred the formation of the commission after the victim's family expressed confidence in a newly constituted police investigation team.

The spokesperson, in a statement today, said the Sindh government had taken the concerns raised by Ali's family "extremely seriously" and that a letter sent by the family to the chief minister had been received. "The judicial commission will conduct an impartial and transparent investigation into the murder case and examine any shortcomings in the investigation, important aspects and evidence requiring further inquiry," the spokesperson said.

The statement added that the commission would also review the role of police, medico-legal officers and other relevant officials. It may recommend action if negligence, dereliction of duty, professional misconduct or tampering with



evidence was established.

According to a spokesperson, the commission would have the authority to recommend further investigation and forensic analysis. Under the Sindh Tribunals of Inquiry Ordinance 1969, it would have powers equivalent to those of a civil court and would be able to summon witnesses, record statements on oath, and requisition documents and records. "The chief minister has directed all government departments, institutions and officials to fully cooperate with the commission, while the Home Department will provide the necessary secretariat support," the spokesperson said. The statement said that the commission would submit its report, findings and recommendations to the Sindh government within 30 days of its establishment. Its term may be extended if required to ensure a complete and fair investigation. The spokesperson said the commission would comprehensively review the investigation procedure and the role of relevant authorities, and would have full authority to recommend appropriate action in accordance with the law. "The Sindh government stands with the family of Ali," the spokesperson said, adding that a transparent judicial inquiry would address the family's legitimate concerns and further strengthen confidence in the rule of law.

The final decision is expected to be announced soon after consultations within the PML-N leadership are completed. The meeting also covered the political situation in the country and other important matters, according to sources.

CDF Munir to visit Tehran on Monday: Iranian foreign ministry

STAFF REPORT, Chief of Defence Forces (CDF) and Chief of Army Staff (COAS) Field Marshal Asim Munir will visit Tehran on Monday, Iran's Foreign Ministry Spokesperson Esmail Baghaei said on Sunday, according to Iran's state-owned Press TV. The visit aims to bolster bilateral cooperation and build on "Pakistan's efforts to help strengthen peace and security in the region," Baghaei said in remarks carried by Iran's state-run news agency IRNA,

Anadolu reported. Baghaei added that CDF Munir would hold discussions with senior Iranian officials during the trip. Two Pakistani government sources confirmed CDF Munir's visit to Reuters, with the first source saying that Iran and Pakistan were in direct contact. A second source said the talks would also address recent developments in the conflict, including US President Donald Trump's threat of tougher sanctions on Iran.

Jhang: Case Registered Over Death Threats to Senior Journalist

Satellite Town Police have registered a case against unidentified suspects for allegedly issuing death threats to senior journalist Rana Muhammad Ghulam Arif.

According to details, Rana Ghulam Arif, a senior member of Jhang Press Club and a representative of a private TV channel, was returning home after offering Maghrib prayers when three unidentified men riding two motorcycles intercepted him on the way. The suspects allegedly threatened him with serious consequences if he continued carrying out his journalistic duties and warned that he would be



killed if he refused to comply. Taking advantage of the darkness, the suspects fled the scene.

On the application submitted by Rana Muhammad Ghulam Arif at Satellite Town Police Station, the local police registered a case and launched a search for the suspects.

Journalistic circles in Jhang have strongly condemned the death

threats allegedly issued to senior journalist Rana Muhammad Ghulam Arif by elements attempting to prevent him from performing his professional duties. They have demanded that District Police Officer Jhang Sajid Hussain ensure the immediate arrest of the suspects and that they be given exemplary punishment in accordance with the law.

Members of Jhang Press Club expressed complete solidarity with Rana Muhammad Ghulam Arif and made it clear that if any delaying tactics are used in the arrest of the suspects, a nationwide protest will be announced, which will continue until the accused are arrested.

CDA approves 23 commercial building plans in four DVC meetings

APP- ISLAMABAD: The Capital Development Authority (CDA) has approved 23 commercial building plans out of 32 cases presented before the Design Vetting Committee (DVC) during its last four meetings held on June 4, June 16, July 30 and August 20, 2026.

According to the CDA, a total of 40 commercial building plan cases were scheduled for consideration during the four meetings. However, eight cases were withdrawn by architects and sponsors before the meetings due to incomplete documents and failure to meet the required conditions.

Of the remaining 32 cases presented before the DVC, 23 were approved while some cases were postponed due to incomplete presentation of basic parking arrangements and other mandatory parameters by architects and designers.



The CDA said the postponed and deferred cases would be presented again before the DVC after completion of all required documents and fulfillment of the relevant requirements. An advisory has also been issued to architects in this regard.

Five cases could not be presented because the concerned clients or architects were absent.

The CDA said, on the directives of Prime Minister Shehbaz Sharif, Interior Minister Mohsin Naqvi and CDA Chairman, the authority is working to facilitate investment in

Islamabad, simplify business procedures and speed up approval of building plans while ensuring public safety. Under the revised procedure, the names of building owners as well as architects and consultants will be mentioned in the final approval letter issued by the DVC. Their names will also be displayed at the construction site during the construction period. The CDA said the measure would help fix responsibility in case of any unauthorized change in the approved design, with legal action possible against the owner, architect or consultant responsible for the violation. The authority said that while the approval process was being made easier and faster, additional responsibilities were also being placed on owners, architects and consultants to ensure compliance with approved designs and regulations.

Serious gaps remain in joint GCC-EU security efforts

When the Gulf Cooperation Council and EU heads of state and government held their first summit last October, they endorsed the blueprint proposed by their ministers on security cooperation. While the two blocs have been closely engaged for decades, mainly on economic and political issues, it was the first time that they decided to work closely on security, as part of their intention to “elevate their strategic partnership to the next level,” by working together to safeguard “global and regional security and prosperity, including preventing the emergence and escalation of conflicts and resolving crises,” according to the joint communique issued at the time.

Regional security, whether in the Middle East, Europe or elsewhere, has to be anchored in “multilateralism, international law and international humanitarian law, as well as sustainable development and prosperity,” in a reference to the weakening, if not total abandonment, of these principles in many parts of the world.

Nine months after that summit was held in Brussels, it is appropriate to assess how much has been done in security cooperation. A meeting of experts was held this week in Cambridge, a neutral territory, to evaluate progress. The meeting was organized by the Gulf Research Center, a well-established Saudi-based think tank. The GRC, celebrating its 25th anniversary this year, is probably the most prolific producer of scholarly and policy-oriented literature on the Gulf. As part of its program, it organizes an annual gathering in Cambridge of academics and policymakers from around the world, to discuss Gulf-related issues over several days of intense deliberations. This year marked the 15th of such convocations; there was more than 400 in attendance. Saudi Foreign Minister Faisal bin Farhan opened the meeting, followed by the GCC Secretary-General Jassem Mohammed Al-Budaiwi, and other senior officials from the two organizations.

Although the GCC-EU security dialogue started only last year, it has made considerable progress in delineating the parameters of cooperation on some specific issues. The

summit agreed to “deepening security cooperation, including on counter-terrorism, maritime security, cyber issues, nonproliferation, and disaster preparedness and emergency management.” In meetings held since the summit, the two organizations agreed on detailed frameworks for each of these five security areas; the next step will be their actual implementation. They also agreed to explore cooperation on peacebuilding efforts such as mediation and negotiation, and combating organized crime, drugs, human trafficking, and smuggling.

On regional security, mediation and conflict resolution, much has been done, especially by the GCC side, but there are serious gaps given the severity of the ongoing crises. There are at least five areas where the two blocs need to double their efforts to live up to the promises made in the October summit to work together toward safeguarding regional security. First, there is the Gaza genocide. The mass starvation and forced displacement of Palestinians have only intensified in recent months. While GCC states, especially Qatar, have been heavily involved in trying

to achieve a ceasefire and allow aid in scale and without hindrance, it is no secret that the EU is divided and, in fact, a few of its members are providing political and material support for the mayhem perpetrated by Israel. Because of the rules of unanimity and weighted majority, the EU has been paralyzed by this division. It has not been able to get its members to agree on an effective course, such as using the leverage of its association agreement with Israel. Rule of weighted majority gives more leverage to large EU member states, who have been able to block action by the organization. In the words of one participant in the Cambridge discussions, the result has left the EU “sitting on its hands,” satisfied with issuing occasional statements expressing concern about Gaza. Similarly, while good progress has been made on plans for the day after in Gaza by the Arab League, Egypt, and others, the EU has yet to lend effective support for this plan. Second, on the two-state solution, Saudi Arabia and a number of partners are making great efforts. One achievement has been the establishment of the Global Alliance

for the Implementation of the Two-State Solution, which includes about 100 countries and organizations from around the world. It has held several substantive meetings dealing with different aspects of this challenge. These efforts are being undermined by Israel so far ruling out negotiations and continuing to change facts on the grounds in the West Bank, including expanding settlements and unleashing unchecked violence against Palestinians. The aim is to make a two-state solution impossible to implement. Although the EU is part of this global alliance, it has yet to use its considerable leverage to get Israel to change course.

Third, on the Israel-Iran war, the EU appears to be aligned with the GCC position. Both are pushing for a diplomatic solution and a return to the nuclear talks in order to prevent a likely resumption of hostilities. Both organizations believe that a military solution is not desirable or effective. Fourth, on the Syrian Arab Republic, the two groups are aligned and have welcomed the new government, which took charge last December.

Lost cause? Let the people of Lebanon have their say

There is a strange situation in Lebanon. For decades, politicians and their staff have been permanently present on the media scene — commenting, contesting, making their clan’s voice heard, and, in short, occupying space. This was true whether in opposition or government. Today, there is a period of quasi-silence. This silence indicates a loss of direction and an inability to read what is coming next regionally. There is another serious and pressing element that is changing the equation: the erosion of security and the impact of the difficult situation in the Syrian Arab Republic. While the new leadership in Syria faces a lot of challenges and risks, the one that presents the biggest danger for Lebanon is not the military clashes between communities, but the lack of order and security, a threat that can easily spread. Syria’s security forces are unprepared to fight crime due to corruption, fragmented control, and, as stated, much bigger issues than public safety. This situation creates great instability for Lebanon, as organized crime does not stay within borders. As the new president, Joseph Aoun, came to power, most Lebanese — some politicians included — hoped he would deliver on his promises to restore sovereignty to the country. Many imagined that a negotiated outcome with Hezbollah was possible and that soon Lebanon would be back to its short-lived “Switzerland of the Middle East” model. Close to seven months later, the optimists — not to call them naive — agree with the cynics of the first hour that this is just quixotic. There was never going to be, and never will be, a negotiated outcome with Hezbollah. We nevertheless need to put things back into perspective. Aoun came to power after Israel defeated Hezbollah using strikes that brought the Iranian proxy to a level of vulnerability never witnessed before. This extreme weakness, and the shell-shocked status of Hezbollah with the change of regime in Syria, made people believe that this was the perfect time. Is it a lost opportunity, just like what happened in the 2000s, not taking the bold step needed and losing the window to make a real change? No one knows. Perhaps, despite years of US support and financing, the Lebanese armed forces still do not represent the stick that can challenge Hezbollah. Or perhaps the answer is simply closer than people think. There is no doubt that even if negotiated, projecting strength would be a necessity. This does not exist today.

There is also within Lebanon an echo of what we see in Western capitals. We cannot ignore the protest posters in New York showing an image of Iran’s Supreme Leader Ali

Khamenei with a slogan telling people to be on the right side of history. Yet, there are, even in Lebanon, people who are puzzled about what comes next. This is why it is time to leave the decision to the people in Lebanon.

The electoral system for years has been carved out by politicians to accommodate their deals. They have been, in a sense, accomplices of Hezbollah. It is time to ask the people what they want. It is time to put forward two questions to the people of Lebanon. The first is: Do you back the sovereignty of the country? And the second question: Do you prefer a centralized political system or a federation?

There also should be a two-level court — one for the entire nation and one for each community. It is now important to see what each community needs and wants for the future. There is no doubt that, for example, today the Sunni community — to which I belong — expects the change of regime in Syria from a pro-Iran to a Sunni one that is representative of the majority of the Syrian population to work to their advantage in the long term. In my opinion, Lebanon’s specificity will clash with the uniformity of the Syrian model. This was true yesterday and will still be true tomorrow. Yet, it is this entrenched thinking that needs to be destroyed. This historical clan setup has partially been responsible for the ills of the country. Whether Hezbollah or the groups before it, it is the same cycle. I would like to see this setup and political system obliterated. I believe that federalism will bring stability to Lebanon. Yet, perhaps I am a tiny minority within the country or my community. This is why reverting to the people is important. It is also important to have a view of what each community needs and wants. This should be stated by the people and not the clan leaders who have perpetuated the cycles generation after generation. If we believe in the sovereignty and independence of Lebanon, we cannot be influenced by how the geopolitical shifts affect our community in the balance of power. It is contradictory. We need a system that gives each citizen within each community the capacity to lead a stable life. What would be the outcome of such referendums? How to manage fragmented results where a community or a group of communities vote differently? What happens if people vote against the state? Does this mean that all communities can arm themselves again? What if they vote for sovereignty — who will execute the will of the people? There are many unanswered questions. Yet the main objective should be to initiate a dialogue, or perhaps accept that, for now, Lebanon is still a lost cause. Either way, the people will know.

Protecting Sudan’s children from war and starvation

In the midst of Sudan’s relentless civil war, children have increasingly become the primary victims of a brutal and indiscriminate violence that shows no sign of abating. In a single weekend of attacks this month, at least 24 boys and 11 girls were reportedly killed in communities around the city of Bara — a tragic toll that drew urgent condemnation from UNICEF and reignited global concern over the war’s deepening atrocities.

These children were not caught in the crossfire by accident — they were targeted in areas of dense civilian population, further proving that the violence has abandoned all pretense of protecting the innocent. This devastating incident stands as a grim symbol of the horrors that have engulfed millions of children across the nation. From killings to starvation, from rape to disease, Sudan’s children are enduring one of the most heartbreaking humanitarian catastrophes of the modern era. The world cannot look away.

The war in Sudan, which erupted in April 2023 between the Sudanese Armed Forces and the Rapid Support Forces, has spiraled into one of the world’s most catastrophic and underreported crises. What began as a power struggle between two rival military factions has degenerated into a total collapse of law, order and human dignity. Now in its third year, the conflict has displaced millions, decimated infrastructure and created a humanitarian vacuum that is being filled with starvation, disease and death.

Nowhere is this more tragically evident than in the suffering of Sudan’s children. According to UNICEF, the number of children in need of humanitarian assistance has doubled since the war began — from 7.8 million to an estimated 15 million. These are not just numbers. They represent children who have been torn from their homes, orphaned by shelling, starved by blockades, denied medicine and robbed

of education. These are lives suspended in trauma, childhoods stolen in real time, futures endangered before they ever had a chance to begin.

The violence against children is not limited to bullets and bombs. It is structural, systemic and widespread. Malnutrition rates among children have soared, with thousands already perishing from hunger and disease due to the inability of aid agencies to reach them. International relief workers warn that, without immediate humanitarian access, tens of thousands more children in these regions are at imminent risk of dying preventable deaths. Compounding the horror is a health crisis spiraling out of control. Disease outbreaks have flourished in the absence of functioning clinics and vaccination programs. Only 48 percent of Sudanese children now receive basic immunizations — down from over 90 percent before the war. Diseases like measles, cholera, malaria and dengue are spreading rapidly, particularly in makeshift camps and besieged cities where clean water and medicine are nonexistent.

The healthcare system, already fragile before the conflict, has collapsed under the weight of violence, looting and blockades. UNICEF warns that 770,000 children will suffer from severe acute malnutrition this year alone, with more than a million more teetering on the edge. In some areas, the malnutrition levels have reached levels consistent with famine. Children are not simply dying from bullets — they are dying silently from hunger, from diarrhea, from infections that a \$2 vaccine could have prevented. And while their bodies wither, so do their minds and spirits. The psychological impact of this war on children is immeasurable. Many have witnessed their parents killed, their homes burned, their villages razed. Rape and sexual violence are used as weapons of war, with horrifying reports emerging of babies and toddlers being assaulted.

COP30 must make good on past climate pledges

In 2015, the landmark Paris climate agreement set the ambitious but necessary goal of limiting global warming to 1.5 degrees Celsius above pre-industrial levels, and ensuring that the increase stays “well below” 2 C. With the average global surface temperature having already reached 1.1 C above the 20th-century baseline, time is running out to reach this goal. Yet governments so far have failed to agree on a strategy for doing so. At the 62nd session of the UN Climate Change Subsidiary Bodies (SB62) in Bonn last month — the negotiations intended to lay the groundwork for November’s UN Climate Change Conference in Brazil — countries got so hung up on the details of the agenda that little progress was made. Such delays have long characterized the UN Framework Convention on Climate Change, but they are at odds with scientific reality, which demands rapid and unified action.

Building consensus is, thus, a key challenge facing Brazil’s COP30 presidency. The task ahead is formidable not only because of the challenges inherent in the UNFCCC process, but also because four interconnected global developments are undermining trust and impeding multilateral cooperation. First, the global-governance architecture, with the UN at its core, is showing signs of disarray. Institutions that were designed to nurture and facilitate cooperation are increasingly hamstrung by bureaucratic inertia and outdated organizational structures. With reform efforts gridlocked, the UN system risks losing its relevance, and multilateralism its credibility.

Second, the rise of transactional diplomacy has meant countries prioritize their own short-term interests over collective long-term needs. This approach, based on a narrow conception of national interest, effectively precludes broad-based cooperation, as it erodes the norms that have traditionally underpinned international engagement.

Third, compromise is increasingly being rejected in favor of “realism,” leading to extreme polarization and entrenched negotiating positions. Multilateral negotiations frequently come down to the wire, and the results are often disappointing, further encouraging transactional engagement at the expense of cooperation and compromise.

Finally, climate change is increasingly taking a back seat to other challenges, with armed conflicts, a global trade slowdown, intensifying

growth headwinds, and record debt levels consuming countries’ political attention, diplomatic space, and financial resources.

Brazil clearly has its work cut out. Above all, it must resist the tendency for COP presidencies to emphasize fresh agreements and ambitious commitments — the kind that grab headlines and make the negotiations look like a smashing success, but often fall short when the hard work of implementation begins. Brazil’s COP30 presidency must eschew flashy results in favor of pragmatic pathways to deliver on past commitments.

Fortunately, Brazil recognizes this. Its fourth letter to the international community outlines an action agenda aimed at making progress on what the world has “already collectively agreed” during previous COPs and in the Paris climate agreement. Specifically, the agenda seeks to leverage existing initiatives to complete the implementation of the first “global stocktake” under the Paris agreement, which was concluded at COP28.

This focus on previously agreed outcomes is well-suited to the current geopolitical context, in which any agreement can be difficult to reach. Representatives at the SB62 in Bonn did not achieve a consensus, and last month’s G7 summit failed to deliver a joint communique. Rather than perpetuating stalemates, the action agenda invites stakeholders to make progress where agreement already exists.

The agenda also charts the way forward. It is organized into six thematic “axes,” including stewarding forests, oceans, and biodiversity; transforming agriculture and food systems; and building resilience for cities, infrastructure, and water. “Unleashing enablers and accelerators” in finance, technology, and capacity-building — the final, cross-cutting axis — will accelerate implementation at scale. Since responsibility for the implementation and governance of climate policy is distributed among many actors — which must have some level of trust that others are doing their part — the agenda also establishes “transparency, monitoring, and accountability” as top priorities. To this end, Brazil’s COP30 presidency should seek to deliver a set of shared principles and supportive mechanisms. As COP30 special envoys, we extend our full support to the action agenda. By emphasizing consolidation, rather than spectacle, Brazil is setting the stage for a highly productive COP30 — one focused on bridging divides, building trust, and delivering genuine progress. The task ahead is daunting, but the chance to rebuild momentum is real.

Pakistan’s Exports, Industry and Remittances Show Strong Growth

APP- ISLAMABAD: Federal Minister for Planning, Development and Special Initiatives Professor Ahsan Iqbal on Saturday said Pakistan’s economy had entered a phase of greater stability, with exports, industrial activity and remittances showing encouraging growth.

However, he stressed that the next priority was to translate macroeconomic stability into sustainable economic transformation under URAAN Pakistan initiative.

Presenting the Monthly Development Update for August, the minister said the government was committed to regularly presenting a clear and transparent picture of the country’s economic position, progress achieved and challenges requiring continued attention.

He said Pakistan had passed through a difficult period of economic adjustment and the stability achieved over the past few

years had been hard-earned.

“Through URAAN Pakistan, our focus is now to translate this stability into sustainable economic transformation, with exports as a key driver, leading to more jobs, better incomes, greater opportunities for our youth and an improved quality of life for the people of Pakistan,” he said.

Ahsan said the beginning of FY2026-27 had provided encouraging economic signals, with Consumer Price Index (CPI) inflation easing to 9.2 per cent in July 2026 from 11.7 per cent in May 2026. He said the government was continuously monitoring markets and prices through regular meetings of the National Price Monitoring Committee (NPMC), with particular focus on strengthening supply chains, monitoring the quality of essential commodities and taking timely administrative measures to keep essential items affordable.

Workers’ remittances remained a major source of external-sector resilience, reaching US\$3.6 billion in July 2026, up 13 per cent from US\$3.2 billion in July 2025.

The strong start to FY2026-27 followed record remittances of US\$41.6 billion during the previous fiscal year, with the inflows strengthening the country’s foreign exchange position while directly supporting millions of Pakistani households. Industrial activity also showed a significant recovery, with Large-Scale Manufacturing (LSM) recording average growth of 5.0 per cent in FY2025-26 against a contraction of 0.7 per cent in the previous year. The recovery was broad-based, with 16 out of 22 sectors posting positive growth. Automobiles recorded the highest growth of 57.8 per cent, followed by transport equipment 42.4 per cent, electrical equipment 14.3 per cent, tobacco 12.6 per cent and food 7.0 per cent.

The external sector also started FY2026-27 on an encouraging note as goods exports increased by 9.4 per cent to US\$3.0 billion in July 2026 from US\$2.8 billion a year earlier. Total exports of goods and services rose by 13 per cent to US\$3.9 billion from US\$3.5 billion during the same month of the previous year. Growth was supported by surgical goods, up 16.3 per cent, food 8.0 per cent, leather goods 7.8 per cent and textiles 3.9 per cent. Information and Communication Technology (ICT) exports rose to US\$417 million in July 2026, highlighting the growing potential of technology and digital services as an important source of export earnings. Imports of goods and services, meanwhile, increased by 13 per cent to US\$7.3 billion in July 2026 from US\$6.5 billion in July 2025, reflecting strengthening domestic economic activity and higher demand for productive and capital goods.

SP Saddar Zone Kazim sets anti-crime priorities, orders full-throttle action under ‘No to Weapon’ Drive

APP- ISLAMABAD: Superintendent of Police (SP) Saddar Zone Kazim Naqvi chaired an important meeting with officers of Tarnol Circle, reviewing the crime situation and directing intensified action against criminal elements, illegal weapons, display of arms and aerial firing.

An official told APP on Sunday that the meeting reviewed in detail the overall crime situation, progress in criminal cases, pending investigations and ongoing action against criminal elements, said a press release here. He ordered vigorous action under Islamabad Police’s “No to Weapon” campaign against possession of illegal arms, display of weapons and aerial firing.

The SP Kazim also reviewed pending investigations and directed officers to improve the pace and quality of investigative work.

He stressed that effective measures should be taken to provide swift justice to citizens, while sustained action against criminal elements should continue to maintain a safe and peaceful environment.

Dark tints draw ITP action as over 450 vehicles challaned in one month

APP- ISLAMABAD: Islamabad Traffic Police (ITP) has taken legal action against more than 450 vehicles with tinted windows during the past month, stepping up enforcement across the federal capital under its zero-tolerance policy against traffic violations.

An ITP official told APP on Sunday that enforcement against tinted windows and other traffic violations was being further intensified to ensure road discipline and safer travel for citizens.

The official said special traffic squads had been deployed at major roads and intersections across Islamabad to ensure strict implementation of traffic laws.

Chief Traffic Officer (CTO) Kainat Azhar Khan said ITP was taking action against tinted windows and other violations without discrimination under its zero-tolerance policy. She said violations of traffic laws could lead to serious accidents and urged citizens to comply with road-safety rules.

Following traffic laws could protect precious lives the drives and also the other road users, the CTO said.

Kainat urged motorists to demonstrate responsible behaviour and cooperate with ITP for safe and smooth travel. She said Islamabad Traffic Police was ensuring uniform and indiscriminate enforcement of traffic laws across the capital.

Governor KP assures support to Afghan medical graduates facing PMDC issues



APP- ISLAMABAD: Governor Khyber Pakhtunkhwa, Faisal Karim Kundi on Saturday assured full support to Pakistani graduates of Afghan medical universities in resolving issues related to the Pakistan Medical and Dental Council (PMDC).

Talking to a representative delegation of the affected graduates in Islamabad, the Governor said the matter would be taken up with the relevant forum and every possible assistance would be extended within the constitutional and legal framework.

The delegation, comprising Dr Asif Afridi, Dr Waqas Akbar, Dr Asif Nabi and Dr Samar, informed the Governor that the Afghan medical universities where they had secured admission were recognised by the PMDC at the time of their enrolment.

They said subsequent changes in

PMDC policy were also being applied to students already enrolled and graduates, creating serious difficulties for them. The delegation also maintained that certain information regarding their case did not fully reflect the facts.

Governor Kundi said the country’s youth were its greatest asset and resolving their problems was a collective responsibility. He added that Pakistan Peoples Party Chairman Bilawal Bhutto Zardari remained committed to safeguarding the rights of young people.

He directed the relevant authorities to contact the PMDC and other concerned institutions to facilitate the resolution of the graduates’ legitimate issues.

The delegation thanked the Governor for hearing their concerns and assuring his cooperation.

ICT Police sweep Capital in 145 grand search operations, screen over 9,300 people in August

APP- ISLAMABAD: Islamabad Capital Territory (ICT) Police carried out 145 grand combing and search operations across the federal capital during August, screening 9,317 people and 3,993 households as part of intensified efforts against criminal elements and to strengthen public safety.

An official told APP on Sunday that the operations were conducted in different areas of Islamabad on the directions of the IGP Islamabad. During the operations, police checked 274 hotels, 1,027 shops, 4,908 motorcycles and 1,720 vehicles.

The official said 251 suspicious individuals, 453 motorcycles and five vehicles were shifted to the respective police stations for further verification and scrutiny. Police also arrested four suspects for allegedly possessing drugs and illegal weapons during the operations.

The recoveries included ice, a dagger, three pistols and ammunition.

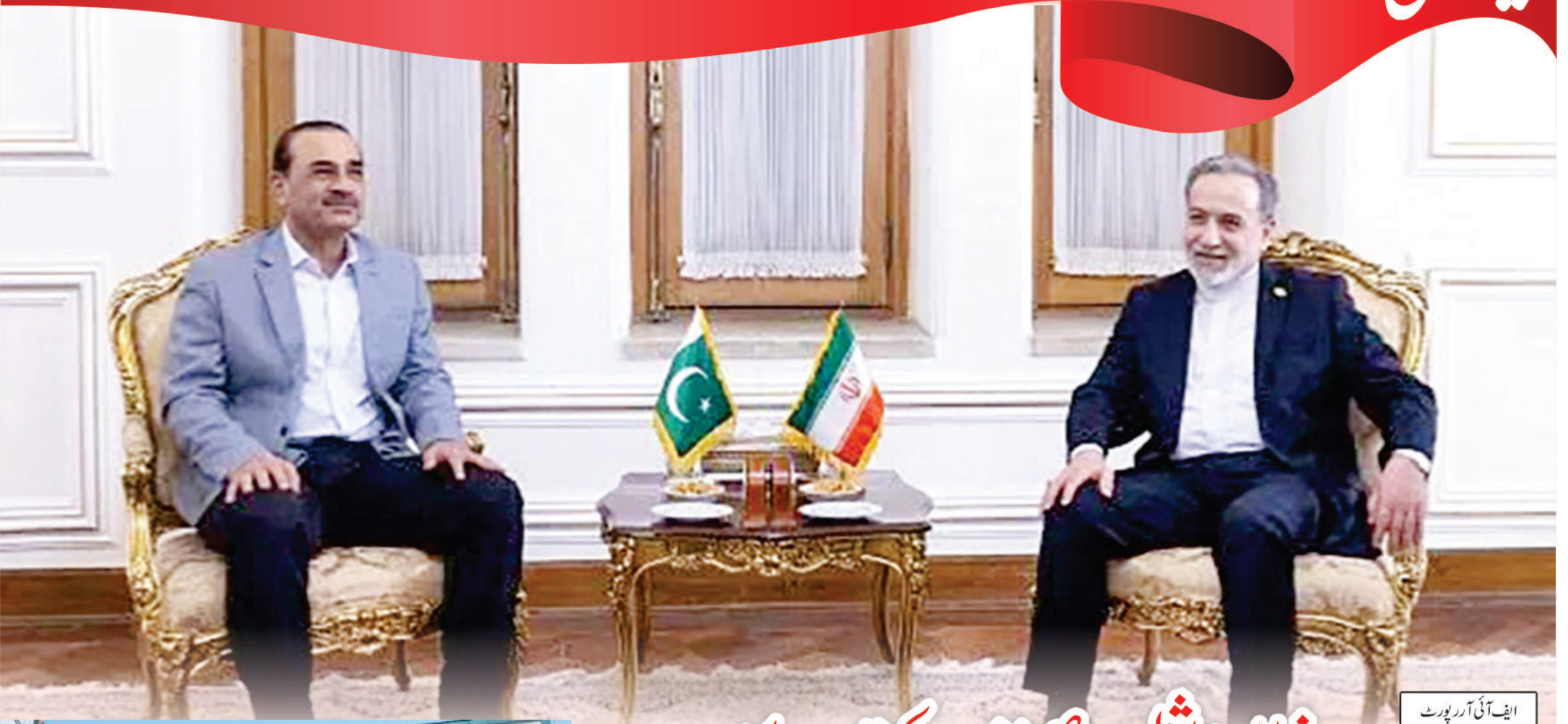
DG Khan Division has sensitive law-and-order environment owing to its proximity to provincial borders and the strategically important tri-border areas.

Hull humiliate United in Premier League opener



SPORTS DESK, LONDON: Manchester United crashed to a humiliating 2-0 defeat at promoted Hull on Saturday in a dismal start to their Premier League campaign.

Michael Carrick's side were rocked by first half goals from Semi Ajayi and Nobel Mendy at the MKM Stadium.

Hull, who are back in the Premier League for the first time since 2017, were without 10 players due to injury but still put woeful United to the sword with a vibrant display.

It was a chastening opening to the new season for United, who are expected to mount a title challenge after finishing third last term. There was scant evidence that United are capable of going toe to toe with champions Arsenal on a dispiriting afternoon on Humberside.

Youri Tielemans and Andrey Santos were anonymous in their United debuts in midfield after joining from Aston Villa and Chelsea respectively.

Carrick laughed off claims that United have been handed an easy start to the season, with their trip to Hull followed by a home game against Ipswich, another of the promoted teams.

The United manager's caution proved prescient.

Former England captain Alan Shearer summed up United's malaise with a damning verdict. "Man United have been shocking, no hunger, they've been terrible," the BBC pundit said.

Carrick's steady demeanour during his interim spell after Ruben Amorim's turbulent reign played a major role in United's revival last season.

But, now installed as permanent boss, Carrick is expected to mount a challenge for United's first English title since 2013, adding a layer of pressure he did not have to endure last season.

Carrick has been asking for more signings and United have agreed a deal for Brighton midfielder Carlos Baleba.

He will be demanding even more after this wretched performance. Last season, Hull became the first team to finish sixth in the Championship and earn promotion via the play-offs since Blackpool in 2010. Tigers' boss Sergej Jakirovic had insisted this week that Hull could prove the doubters wrong after a host of pundits wrote them off as relegation certainties. Even Jakirovic must have been pinching himself to make sure he wasn't dreaming during Hull's first win over

United since 2017. Initially, United were on top and Luke Shaw's cross reached Bryan Mbeumo for fierce strike that was repelled by Hull's debutant keeper Konstantinos Tzolakis. United threatened again moments later when Noussair Mazraoui picked out Matheus Cunha for a low drive that Tzolakis saved at full stretch.

But Hull served notice they could trouble United as Ryan Giles' cross found Oli McBurnie for a header that forced a good stop from Senne Lammens. United's defensive vulnerability at set-pieces was brutally exposed in the 17th minute. McBurnie easily evaded sloppy marking at a Hull corner and drilled a strike that Lammens could only push out to Nigeria defender Ajayi, who gleefully poked home from close-range.

Thauvin double helps Lens thrash Auxerre

SPORTS DESK, LENS, FRANCE: Lens captain Florian Thauvin scored two penalties as Lens thumped Auxerre 5-2 in their first game of the French Ligue 1 season on



Saturday. Thauvin converted from the spot either side of the break as the northerners continued their good form from last season when they finished second in the table behind Paris Saint-Germain.

Last weekend, German coach Dino Toppmoller won his first competitive game in charge of Lens, beating PSG in the French Champions Trophy.

"The most important thing was to win, and to start the season well," defender Matthieu Udol told reporters.

"It was also important to back up last week's result." Auxerre had defender Christ Massoko sent off in the first half for a foul on Lens attacker Abdallah Sima. Thauvin, a World Cup winner in 2018, opened the scoring after just 12 minutes after Belgian midfielder Arthur Piedfort handled the ball in the hosts' box. Thauvin's low finish sent the packed Stade Bollaert crowd wild before the visitors were down a man as Massoko saw red 10 minutes before the interval.

Sadiq urges Pakistan to rethink team balance

SPORTS DESK, KARACHI: Former Pakistan Test opener Sadiq Mohammad has urged the team management to rethink its combination for the second Test against England, saying Pakistan's defeat at Headingley exposed the weakness of playing an extra batsman at the expense of a fifth frontline bowler.

Pakistan were beaten by an innings and 103 runs in the opening Test, with England's seamers exploiting the conditions to put the visitors' batting under sustained pressure.

Sadiq said Pakistan must select a side better suited to English conditions, where changes in weather can quickly bring seam and swing into play.

He questioned the long-standing policy of selecting seven specialist batsmen in Test matches, arguing that the additional batsman offered less value than another genuine wicket-taking option. "I could never understand the strategy of selecting seven batsmen," Sadiq told The Express Tribune.

Padikkal ton powers India to 300-5 against Sri Lanka



SPORTS DESK, Colombo: Top-order batter Devdutt Padikkal's fine form continued as he scored 117 to help India reach 300-5 at stumps on the opening day of the second Test against Sri Lanka in Colombo on Sunday.

Padikkal, a late injury replacement ahead of the series, had scored 167 and 44 in the first Test to win the Man-of-the-Match award as India won by 165 runs in Galle.

He followed up with another century, but only after being dropped twice early in his innings after India opted to bat first.

Padikkal was first dropped by Sonal Dinusha at backward point before he had opened his account, then received another reprieve on two runs when captain

Dhananjaya de Silva spilled a chance at slip.

Padikkal added 120 runs for the third wicket with captain Shubman Gill to put India in control before off-spinner Keshara Nuwantha finally ended his stay.

Since Gill moved down to number four after assuming the captaincy, India have tried several players in the number three position. Padikkal's performances in this series have made him a strong contender for the role.

Seamer Asitha Fernando was the pick of Sri Lanka's bowlers, returning figures of 3-46.

He dismissed opener Yashasvi Jaiswal for 45 in the morning session, with the dismissal followed by a heated exchange between the two.

Fernando struck again to remove Gill, who slashed at a delivery moving away from him and was caught behind.

With the second new ball, Fernando produced another important breakthrough when he bowled Ravindra Jadeja.

Debutant off-spinner Saransh Jain was unbeaten on four at stumps, with Dhruv Jurel seven not out at the other end.

Wicket-keeper Rishabh Pant was struck on his left forearm while attempting to pull Lahiru Kumara and was forced to retire hurt when on three.

Only 85 of the scheduled 90 overs were bowled on the opening day.

Earlier, Sri Lanka handed opening batter Kamil Mishara his Test debut, with Nishan Fernando left out. Pasindu Sooriyabandara, who came on as a concussion substitute for Dinesh Chandimal in the first Test, also featured in the starting eleven for the first time.

Sports Desk added: India's innings was built around long periods of controlled batting, with Padikkal and Gill absorbing pressure before Jadeja added useful runs in the final session. Sri Lanka's bowlers managed to make late inroads after the new ball was taken at 80.1 overs, removing Padikkal and Jadeja.

The match also marked Test debuts for India's Saransh Jain and Sri Lanka's Kamil Mishara. Pakistan's Ahsan Raza is one of the on-field umpires, with Bangladesh's Sharfuddoula serving as the DRS official.

In his first ever Masters 1000 final, The four-time ATP Tour champion will face American Tiafoe, who beat compatriot Brandon Nakashima 7-5 6-3.

The Americans traded four consecutive breaks before drawing level at 3-3 in the opening set, but Tiafoe held to love in the seventh game and broke again to move 6-5 ahead before serving out the set. The 27-year-old broke Nakashima for a 3-2 lead in the second set and sealed victory by holding to love.

Fils beat Cobolli -- the Roland Garros finalist from Italy -- for the third time in their career series to become the youngest French Masters finalist since a 20-year-old Richard Gasquet in Toronto two decades ago.

The 68-minute match finished with perfect timing as rain began only minutes after the conclusion, briefly delaying the start of a women's semi-final between



holder Iga Swiatek and Jessica Pegula. Fils said the weather delay that had halted the start of his match as the players took to the court was difficult to deal with.

Poland Work Visa Scam: FIA Arrests Suspect

APP- ISLAMABAD: The Federal Investigation Agency (FIA) Anti-Human Trafficking Circle (AHTC) Rawalpindi arrested a suspect in a Rs 1.2 million Poland work visa fraud case, while efforts were underway to apprehend his alleged accomplice. An FIA official told APP on Sunday that the arrested accused was identified as Ehsanullah son of Sajjad Gul, against whom a case had been lodged following an investigation into the visa fraud. The investigation revealed that Ehsanullah, and his alleged accomplice Zeeshan Abbasi, son of Noor-ur-Rehman had jointly received Rs 1.2 million, through cash and bank transactions, from complainants Atif Ali, son of Sharafat Hussain and Khurram Shehzad, son of Riazat Khan. The official said the money was allegedly obtained on the promise of arranging Poland work visas for the complainants, but the accused failed to provide the visas as promised.

A case has been registered under Sections 18 and 22 of the Emigration Ordinance, 1979.

Jl intensifies fuel levy protest, calls for nationwide strike after 12th Rabi ul Awal



MONITORING DESK, Jamaat-e-Islami (JI) Pakistan Emir Hafiz Naeemur Rehman on Sunday stepped up pressure over the petroleum levy, announcing a nationwide shutter-down strike after 12th Rabi ul Awal as the party’s sit-ins entered their eighth day. 12th Rabi ul Awal, the third month of the Islamic lunar calendar, marks Eid Milad un Nabi (Peace Be Upon Him), commemorating the birth of Prophet Muhammad (PBUH), and falls on August 26 this year. Addressing a press conference in Lahore, Hafiz Naeem said the party’s campaign was progressing “in the best possible manner” and demanded that the federal government reduce petroleum product prices.

He said the country could not progress in the presence of flour and sugar mafias, while farmers were also struggling to obtain fertiliser at affordable prices.

“Government officials are driving expensive vehicles with our money,” the JI chief said, criticising the government spending.

Hafiz Naeem said the party would launch a nationwide shutter-down strike after Eid Milad un Nabi (PBUH), making it clear that the protests would not end merely on government assurances.

He said negotiations would no longer take place on the basis of the government asking protesters to end their sit-ins in return for promises to meet their demands.

“The sit-in will end only when the

government implements our demands in practical terms,” he said.

The JI protests come amid growing public concern over rising fuel prices, inflation and soaring electricity bills. Supporters have been staging sit-ins since August 16 outside the Punjab chief minister’s residence in Lahore and governor houses in Karachi, Quetta and Peshawar.

The federal government is facing mounting pressure over successive fuel price increases and their impact on inflation.

The pressure has intensified after authorities shifted from a 15-day fuel price review to a daily mechanism amid volatility in global oil prices following renewed hostilities in the Middle East.

The fuel price dispute has also triggered protests and demands from transporters and petroleum dealers.

Earlier this week, the All Pakistan Goods Transport Alliance suspended its nine-day nationwide strike for 40 days after receiving assurances from the federal and Sindh governments on key demands, including petroleum pricing.

The Pakistan Petroleum Dealers Association had also issued a 72-hour ultimatum to the government earlier this month, seeking resolution of outstanding issues and implementation of commitments made by the petroleum minister.

Saudi Business Community Shows Strong Interest in Pakistan Investment

APP- ISLAMABAD: Federal Minister for Investment and Board of Investment (BOI) Chairman Qaiser Ahmed Sheikh met with a delegation of the Saudi Investment Forum to discuss ways to strengthen economic ties between Pakistan and Saudi Arabia and promote greater Saudi investment in Pakistan. The delegation was led by Kunwar Qutbuddin and included Engr. Ghulam Safdar, President of the Pakistan Investor and Business Forum (PIBF), and Raja Riaz, Chairman of Mokamela International LLC. It said that the previously separate forums in Riyadh and Jeddah had been consolidated into a single forum representing Saudi Arabia, with a network of more than 400 businesses.

The delegation said the forum aims to provide a platform for credible businesses to develop commercial, investment and business-to-business links.

It also highlighted Saudi Arabia’s growing role as a regional center for trade and investment and discussed opportunities for partnerships, joint ventures and long-term business cooperation.

Welcoming the delegation, Qaiser Ahmed Sheikh said Pakistan attaches great importance to its relations with Saudi Arabia and wants to further strengthen economic and investment cooperation between the two countries.

He said the BOI would facilitate genuine Saudi investments by helping them identify investment opportunities, coordinating with relevant government institutions and addressing issues that may arise during the

investment process.

The minister briefed the delegation on the role of BOI’s Honorary Investment Counsellors in promoting Pakistan’s investment potential in international markets. He also highlighted government efforts to improve the business environment through regulatory reforms aimed at simplifying procedures and reducing unnecessary requirements.

Qaiser Ahmed Sheikh said the Business Facilitation Center (BFC) was helping investors and businesses deal with government departments through a coordinated, single-window system. He identified agriculture, information technology, mining, manufacturing, energy, infrastructure, logistics, food processing and tourism among the sectors offering investment opportunities in Pakistan.

Hina Javed murder case: Rawalpindi court sends husband, servant on 3-day physical remand

APP- RAWALPINDI: A duty magistrate in Rawalpindi on Sunday remanded the husband and servant of Hina Javed in police custody for three days in her murder case.

Hina was found dead in the washroom of her apartment in Askari Apartments in Rawalpindi on Thursday evening. Police said that the body bore signs of torture, with a wire fastened around her neck and tied to the shower rod. They detained her husband and a servant in relation to the case.

Today, the suspects were produced before a duty magistrate by police, who sought their remand for further investigation. The court granted the Civil Lines police their three-day physical remand, directing authorities to submit a progress report after the remand’s completion.

A first information report of the case was registered

on Aug 20 at the Civil Lines police station under Sections 302 (premeditated murder) and 34 (common intention) of the Pakistan Penal Code.

The complainant, Hina’s brother, Fahid Javed, alleged in the FIR that his sister had been murdered by her husband, her father-in-law and their domestic servant.

Fahid told police that he received a telephone call from his sister’s father-in-law at 6:53pm on Thursday, informing him of an emergency at their residence. He said he rushed to the apartment with other family members and arrived there at 7:23pm. He claimed that when he arrived at the residence, he found his sister’s body in the bathroom. The complainant further alleged that his sister had been subjected to “severe torture and mistreatment” by her husband.
